Enrollment Instructions:

Please read the following information regarding NGS enrollment for EDI (837) and ERA (835).

NGS has changed their enrollment process, guides to assist in completing the required on-line forms can be found on their site on the EDI E-Signature User Guide found <u>here.</u>

All forms should be signed electronically by the Authorized Official for the organization.

To begin the Enrollment process:

- Go to www.ngsmedicare.com You will either sign in or 'Continue as Guest'
- Navigate to Electronic Data Interchange then EDI Enrollment

Go to the 'Start Enrollment Process' on the EDI Enrollment page. You will be prompted to accept the terms and conditions.

- Select 'I need to complete a Registration Form. (EDI Registration Form includes all EDI Part A and Part B scenarios such as claims and remits)
 - Method of Electronic Submission: Select Clearinghouse
 - Clearinghouse Name: Select Availity, LLC
 - Contact First/Last Name: Enter Client Services
 - o Email: Enter enrollments@availity.com
- General Information
 - Details on how to complete the general information section of the enrollment can be found in General Information topic of the EDI E-Signature User Guide linked above.
- Choose Transaction Status
 - Select the option to 'set up' or 'change' for all transactions you would like to be set up with (837, 835)

After submitting your form you may be prompted to complete additional forms

- EDI ERA Enrollment Form For receiver Electronic Remittance Advise
 - o Enter all required billing provider information
 - Provide Availity's Trading Partner ID: 70000
 - Select Method of retrieval
 - NOTE- Direct from Contractor option is for those submitting claims directly to Medicare
 - If you are receiving ERAs through a Trading Partner other than Availity select 'Change Enrollment' otherwise select 'New Enrollment'
- EDI Registration Form -
 - Select Obtain Trading Partner ID: Availity, LLC 70000
 - Select 837 for batch claims and 835 for electronic remittance advice
